As we close out 2024, I am struck by how far we have come in such a short time. We are growing into our vision as a dynamic organization making tangible strides toward creating a safer, more consistent marketplace for cannabinoid products. As a nonprofit, none of this would be possible without the incredible network of people like you—advocates, professionals, and supporters who believe in our mission.

This year has been monumental for S3 Collective, and your interest in our work drives us to keep pushing boundaries. I am excited to share a few highlights of what we've achieved:

### **Advancing Standards and Research**

- We hosted our first in-person event for regulators, welcoming over 20 state and federal officials to explore how standards, accreditation, and certification programs can advance public health.
- Submitted a [Public Comment](#) on Rescheduling to the DEA along with the Maryland Cannabis Student Association. Over 50 dedicated volunteers reviewed over 100 scientific studies, producing a concise, impactful 42-page submission—ensuring science is permanently on the record.
- Shared knowledge at events like [MJUnpacked](#), universities, and trade shows, bringing attention to the importance of standards and product safety across diverse audiences.

We are excited to build on our efforts in 2024 with several major initiatives, including publishing a multi-year research and standards agenda, providing increased resources to [regulatory agencies](#) on how to utilize evidence-based standards and more.



## Standards Snapshot

Two groundbreaking ASTM D37 standards, [ASTM D8587-24](#) and [ASTM D8588-24](#) were published last month to establish science-based methods for evaluating vape ingredient safety, offering manufacturers clear guidance and providing regulators with critical tools to protect consumer health. [Explore](#) how these standards impact the industry.

Currently, there are no open ASTM D37 ballots.

## Science Spotlight

The [FDA approved a study](#) on cannabis for veterans with PTSD, signaling growing interest in its therapeutic potential. Researchers will assess the effects of high-potency marijuana, filling a critical research gap.

The [DOJ awarded](#) more than half a million dollars to study hemp-derived products. [NIST](#) will analyze chemical composition and label accuracy, while [Sam Houston State University](#) will develop methods to distinguish hemp from marijuana for regulatory and law enforcement use.


## Safety Scoop

The [Massachusetts Cannabis Control Commission](#) identifies ground cannabis dust as a hazardous chemical. Licensees must comply with OSHA standards, implement safety protocols, and protect workers through training, ventilation, and protective equipment.

## Rulemaking Meetings, Regulatory Events, & Public Comments

All times listed are in local time.

- **Alabama** - The next Alabama Medical Cannabis Commission (AMCC) meetings will be on **12/12** and **1/09/25** at 1:00 PM ([join meeting](#), [agenda](#)).
- **California** - The Department of Cannabis Control (DCC) met on **11/21** ([meeting materials](#)).
- **Colorado** - The Marijuana Enforcement Division's (MED) final adopted [permanent rules](#) took effect on **12/04**. The next MED Science & Policy Forum meeting will be on **2/07/25** from 11:00 AM to 1:00 PM. They will also meet on **3/07/25, 4/04/25, 5/02/25, and 6/06/25**. These meetings will address the Metrc remediation symbol (one-time topic on 2/07/25) and have ongoing discussions on Production Batch definitions, testing, and transfers at monthly meetings. Feedback on [additional agenda items](#) is welcome by **12/18**.

- **Delaware** - The next Dover City Council meeting will be on **12/09** at 6:30 PM ([virtual](#)) and will include zoning and licensing regulations for cannabis businesses in Dover, alongside discussions on public safety protocols.
- **District of Columbia (DC)** - The Alcoholic Beverage and Cannabis Administration (ABC) met on **12/04** ([recording](#)).
