Standards Snapshot

- ASTM International's [Committee D37 on Cannabis](#) convened in Louisville, KY, from January 20 - 24. The event offered extensive networking opportunities with industry operators, scientists, and state and federal regulatory agencies. We kicked things off with a workshop on sensory and consumer research for cannabis products, led by Committee E18 on Sensory Evaluation. Workshop participants explored the cannabis consumer-product-production nexus. The week continued with Task Group meetings on topics like hemp testing, occupational health & safety, vaporizer products, pre-roll analysis, and more, alongside a strategic Open Space Technology meeting to

discuss needed industry standards. Lastly, the over a dozen Subcommittees met to discuss recent and ongoing updates on terminology and standards.
