ASTM D37 Open Ballot due by July 25 for the D37.04 Processing and Handling Subcommittee - Specification for the Minimum Quality of Precision Fermented, Semi-Synthetic, and Synthetic Cannabinoids to be Sold into a Legal Market ([WK94959](#))
